Instructions for filing an appeal

Notice of appeal to Town of Drayton Valley Subdivision and Development Appeal Board (SDAB) must be filed in accordance with the *Municipal Government Act* and Town of Drayton Valley Land Use Bylaw 2007/24/D.

When does an appeal need to be submitted by?

- Subdivision Appeals
 - An appeal of the decision of a subdivision authority on an application for subdivision approval must be filed within 14 days of receipt of the written decision of the subdivision authority or deemed refusal by the subdivision authority.
- Development Appeals
 - Appeals made by the applicant for a development permit must be filed within 21 days of the date on which the written decision is made or the date on which the applicant for the development permit is deemed refused.

What needs to be included in an appeal?

- Subdivision and Development Appeal Board Notice of Appeal Form which must be submitted in writing and include:
 - o Your name, signature, and contact information,
 - o The file number and/or legal description of the project, and
 - o the specific reasons for appeal.
- ➤ The appeal fee of \$300.00 as set out in the Town of Drayton Valley's Fee Schedule

If any part of the requirements is missing at the appeal deadline, the appeal will be void and not be processed.

- 1. Appeal fees may be paid by cheque payable to the Town of Drayton Valley. Debit and cash may be submitted if the application is filed in person.
